DIRECTOR'S REPORT
ANDY FRISCH, EXECUTIVE DIRECTOR

For a while at Kainos, we have identified our three main challenges as: meeting the changing needs of our clients as they age, developing programs relevant to the next generation of Kainos clients and dealing with a constantly changing regulatory environment that is placing more demands on us with fewer resources to do our work and meet those demands.

I have spent a lot of time writing, speaking and working on our senior initiatives and people are generally aware of them. It's sad to admit but I basically feel hopeless in being able to have an impact on the regulatory environment which seems addicted to cost cutting and rhetoric that ignores clients/families desires or reality on the ground.

We haven't spoken enough about the services we hope to develop for the next generation of Kainos clients. These clients will have spent a lot more time in fully integrated special education programs, interacting more with general education students and more focused on living independently. They will be looking for solutions like Kainos' Supported Employment Individual Placement Services and our Supported Living Services.

Many of the clients who will be seeking these services have a diagnosis of Autism Spectrum Disorder. Their challenges tend to be more unique with a need for even greater individualization of necessary support services. We already have made strides in strengthening our Supported Employment and particularly our Supported Living Program to meet these needs.

In 2016, we hope to build on the successes we have already had in recruiting the next generation of Kainos clients and develop a cohort of young clients from across our programs and give them the chance to develop venues for volunteer, social and recreational opportunities together. We already have a core group to work with and with a little support, I expect they will be quite active.
