DIRECTOR'S REPORT

If there is one constant this year at Kainos it is change. It is our theme for the year and it is happening all over. In this Klarion, I'd like to share with you some changes that are occurring in our programs right now. After 26 years serving as the La Vista manager, Anne Steinle retired on May 2nd. I remember when Anne first came to Kainos and she spoke of making a year to two commitment to the program. We were so lucky to have her leadership, vision, presence and heart for all those years and she will be terribly missed by residents, families, staff and me. The steady presence of strong program managers like Anne has been a great blessing for Kainos and we can only hope to be so lucky in the future.

Anne had the opportunity to spend a month training our new La Vista manager Meghan Reynard. I am very confident that Meghan's strengths (her warmth, her enthusiasm, her capacity to mentor and lead the La Vista staff and most important her already demonstrated ability to form close, supportive and respectful relationships with the residents) will be critical as we move forward addressing future changes in the program.

At the same time, we have been lucky to find a consultant, Stephanie Guinasso, to work closely with us as we develop and implement changes to our Work activity Program that we have been planning for the past year or two. Stephanie has had great success implementing programs for adults with intellectual and developmental disabilities and her experience and knowledge have already proven to be invaluable. Later this summer, Andrea will be scheduling a family support group meeting to introduce Stephanie and our vision for these new programs.

REBUILDING TOGETHER COMES TO PETES' PLACE

Kainos' Petes Place was fortunate to be selected for a 2016 Rebuilding Together project. For those who are not familiar with Rebuilding Together, they are a nationwide non-profit organization that strives to transform the lives of low income homeowners by improving the safety and health of their homes while revitalizing communities. Each April over 100,000 volunteers complete 10,000 rebuild projects.

Petes' Place received a monumental exterior makeover. Once a nondescript lackluster white house with minimal landscaping and unusable outdoor space, it is now a brightly painted beautiful house with curb

appeal galore and a backyard patio space beneficial to our clients' needs. Led by Mike Lynch of Novo Construction, Petes Place received all new exterior paint, a safe new front entrance, new lighting, drought tolerant landscaping, new exterior doors to utility rooms and a new patio for our clients to enjoy the outdoors. Roughly 30 volunteers showed up on April 30th including members of the Peninsula Sunrise and Woodside Rotary Clubs as well as Kainos staff and clients to ensure the project was a success. Also a very special thank you to Dave Hyman of Encore Performance Catering for providing lunch and snacks for our volunteers!
